

Blessed Companionship Privacy Policy

1. Introduction

Blessed Companionship is committed to protecting the privacy and personal information of users who use this website and its services. This Privacy Policy explains what information we collect, why we collect it, how we use it, how we secure it, and how users can exercise control over their data.

This policy applies to all visitors and registered users of the Blessed Companionship website, including members who sign up, complete profiles, request membership upgrades, and share profiles for matchmaking.

2. Data We Collect

We collect the following categories of information from users to provide our matchmaking, verification, and profile services.

2.1 Account and Authentication Data

- Full name
- Email address
- Password (securely handled by Firebase Authentication)
- Google account name, email, and profile photo when users sign in with Google
- Firebase Authentication UID
- Email verification status

2.2 Profile Information

- Age
- Gender
- City or locality
- Province
- Height and weight
- BMI (calculated from height and weight)
- Complexion
- Blood group
- Sect or religion
- Caste / biradari
- Marital status
- Education level
- Profession
- Monthly income band
- Workplace location
- Relocation willingness
- Housing situation, type, and size

- Short biography
- Disability status and details
- Medical history and medical details
- Children status and number of children
- Father and mother occupation and status
- Family financial status
- Number of brothers and sisters
- Family city of residence
- Family background and values
- Match preferences, including preferred age range, city, education, marital status, religion, profession, and children preferences

2.3 Communication Data

- Phone number, including country code and WhatsApp number
- Consent confirmation for profile posting and verification workflows

2.4 Media and Photos

- Profile photos uploaded by members
- Blurred and original image URLs for profile photo presentation
- Payment proof images or screenshots uploaded during membership upgrade requests

2.5 System and Technical Data

- Information required to operate and secure the site, such as browser type, device model, IP address, and access timestamps
- Data required to support authentication and app usage

3. How We Collect Information

We collect information in the following ways:

- When users create an account through email/password signup
- When users sign in with Google authentication
- When users complete or update their profile in the dashboard
- When users upload profile photos or payment proof images
- When users request verification, membership upgrades, or submit form data

4. How We Use Your Information

The information we collect is used for the following purposes:

- To create and manage user accounts
- To build member profiles for matchmaking and verification
- To verify membership tier and eligibility for premium services
- To communicate with members about account status, verification progress, and support requests
- To show or hide profile details based on privacy controls and admin review

- To preserve profile history and support data updates
- To comply with applicable laws and protect the security of the service

5. Sharing and Disclosure

We do not sell personal data to third parties.

We share information only in the following limited cases:

- With service providers who help us operate the site, such as Firebase Authentication, Firestore, and image hosting providers
- With administrators who manage verification and profile sharing decisions
- With other match seekers only when a profile is intentionally marked as shareable by an admin, and only after the member has agreed to the relevant terms
- When required by law or to protect the rights, safety, or property of Blessed Companionship, our users, or the public

5.1 Public Profile Sharing

Public profiles are only created when an admin approves the profile as shareable. Even then:

- Phone numbers and email addresses are never published on the public profile
- Private photos are never shown on shared profiles
- Only photos explicitly set to public are shown on a shared profile

6. Third-Party Services

Blessed Companionship uses the following third-party services to operate the website securely and reliably.

6.1 Firebase

- Authentication: Firebase Authentication handles sign-up, login, and email verification.
- Database: Firestore stores member profile data, verification status, and associated application state.
- Security: Firestore security rules protect member data from unauthorized access and restrict admin-only operations.

6.2 imgbb

- Profile images and payment proof images are uploaded to imgbb for hosting.
- The app stores only the URLs returned by imgbb in Firestore.
- Blurred versions of images are generated on the user's device before upload to support privacy-first photo presentation.

7. Data Security

We protect personal data with reasonable administrative, technical, and physical safeguards:

- Firestore security rules restrict access to authenticated users and administrators only
- Firebase Authentication secures login and sign-up flows

- Sensitive profile inputs are transmitted over HTTPS
- Passwords are never stored in plain text by the site; they are managed by Firebase Authentication
- Payment proof and photo uploads are handled with secure third-party services

8. Data Retention

We retain personal information for as long as necessary to provide services, support account management, comply with legal obligations, and protect against abuse.

When a user deletes their account or requests data removal, we remove profile details and account records in accordance with applicable law and the capabilities of our service providers.

9. Your Rights

Depending on your jurisdiction, you may have rights including:

- Access to the personal information we hold about you
- Correction of inaccurate or incomplete data
- Deletion of your account and profile information
- Objection to certain uses of your personal data
- Restriction of processing in certain circumstances

10. Children's Privacy

Blessed Companionship is not intended for children under the age of 18. We do not knowingly collect personal information from anyone under 18. If we become aware that a person under 18 has provided personal data without verified consent from a guardian, we will take steps to delete that information.
